# Digital Sisters Grant Program Guide

This guide is for Good Things' network organisations that have been awarded [Digital Sisters Grant](#).

## Key info about this grant

**Good Things program:** Digital Sisters Grant

**Target audience:** Migrant and Refugee women aged 18 – 50 years

**Grant objective:** Use grant funds to provide free digital skills support to migrant and refugee women aged 18 – 50 years in your community.

**Grant term:** 12 months (July 2025 – June 2026)

**Number of people you need to support:** 40 migrant and refugee women (16 women / 40% of the target by 31 December 2025).

## What you need to do

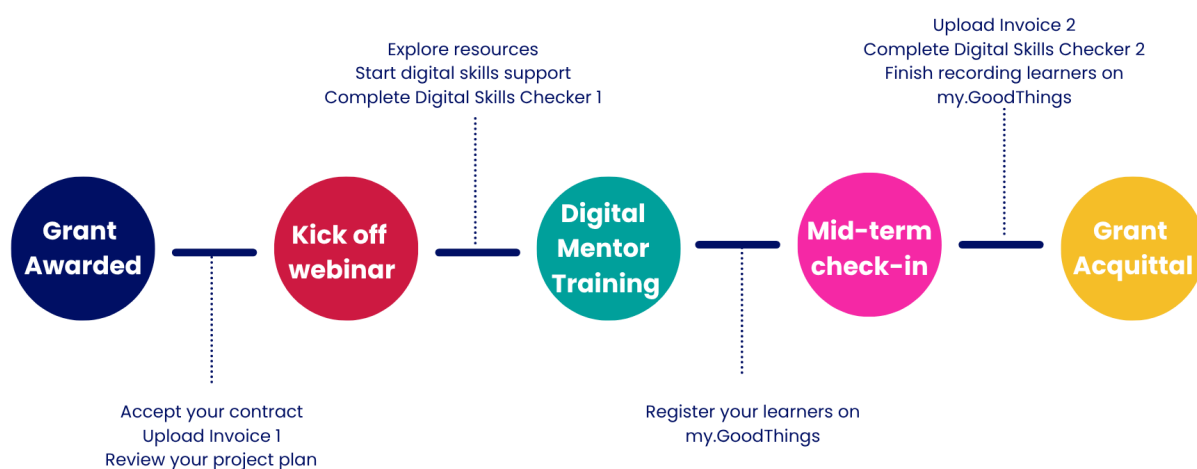
- Nominate at least **2 Digital Mentors** to participate in 1 session of virtual digital mentor training hosted by Good Things Australia. You have the option to select Digital Mentors trained from your existing Digital Sisters Grant or nominate new staff members to attend the online training session.
- Support **40 refugee and migrant women** to improve their digital skills and confidence for life and work.

**Note:** Network Partners who have existing learners from previous Digital Sisters grants who wish to continue their learner journey, can now roll them over into the new contract and they will count towards the contracted number of learners you are required to support. **The maximum number of existing learners who can count towards your target number of learners is 50%. A minimum of 50% (at least 20 of the refugee and migrant women support) must be new learners.**

- Host at least **one promotional event**, by 31 December 2025, to inform the community of the availability of the program
- Complete the mid-term check in
- Ensure learners attending a digital literacy skills session complete a sign-in form
- Ensure learner activity and data is gathered and reported on in Good Things Australia's Learner Management System

- Commit to supporting outcomes measurement and evaluation of the digital literacy program by ensuring **all** Digital Mentors **and at least 50%** of learners use Good Things Australia's digital literacy skills checker tools.
- When possible, participate in virtual community of practice meetings to discuss and share information, data, and good practice
- Ensure all staff and mentors involved in delivering the Digital Sisters project have police checks or Working with Vulnerable People checks
- To ensure efficient communication, ensure your contact details in my.goodthings Network Partner website are up to date and notify Good Things Australia within two weeks of any changes to key staff involved in the Digital Sisters project
- Be prepared to share learner journeys and good news stories so that Good Things Australia can create case studies
- Upon completion of delivery, submit a final report and financial acquittal
- Have public liability insurance

## Your digital skills support

Your organisation can design the digital skills support you provide using this grant funding and the topics you cover to meet the needs of your community. Use your project plan and Digital Skills Checker results as a guide to how you will deliver these topics.

You can choose to deliver your grant-funded support through:

1. **Group mentoring sessions** – Support learners in a group setting. Ensure each participant has a device and guide them step-by-step through topics by using various activities from the [My Good Things Learning portal](#). Use practical activities to make it fun and relevant.
2. **One-on-one support sessions:** Support individual learners in person. Guide them step-by-step through topics of interest by using various resources from the [My Good Things Learning portal](#). Use practical activities to make it fun and relevant.

**Top Tip:** Develop a system for tracking learner progress at the start of your program.

# Reporting requirements

There are four things you need to do to report on and acquit your grant.

## 1. Digital Skills Checkers

Completing baseline and post-support learner surveys – called Digital Skills Checkers – is a grant requirement. At least 50% of your learners must complete both Checkers. The links to the Checkers and their results can be seen in your [my.GoodThings account](#). This will help you to tailor your support to meet your learner's needs. They are also essential for showing impact and helping Good Things Australia secure future government funding. Each completed survey also counts toward your learning targets, so please support learners in completing them.

We know that some program participants are worried about their data safety and privacy and are hesitant to fill out the digital checkers. Please show [this video](#) in your session that explains why we collect data and why it is safe with them.

## 2. Recording your learners

Log in to [my.GoodThings website](#) to register learners who were supported in your Digital Sisters program. This is essential for acquitting your grant and measuring program impact. Use our step-by-step videos and guides to help with the process:

## 3. Midterm Check-In

To have your invoice for the second instalment approved, you must complete an engagement event, support at least 40% of the target (16 learners), and upload their digital checkers and learners' details to the my.GoodThings portal by December 2025.

Your progress will be reviewed by the Digital Sisters project coordinator through a phone call or an online meeting, which you can book [here](#).

#### 4. Final grant acquittal

Acquit your Digital Sisters grant at the end of the term or once targets are met on the [my.GoodThings website](#). Go to **Manage Grants > Funding Award Requirement** to access your online grant acquittal form.

The following questions need to be addressed in the acquittal:

1. What is your first and last name?
2. How many women did you support during the term of the grant?
3. Please provide details of significant achievements or outcomes relating to the project
4. What do you consider to be the most important concern(s) facing the project
5. Please upload your itemised and costed expenditure statement outlining how the grant funds were spent.
  - a. Use the acquittal template provided
  - b. Add comments about how you spent the funds and any variations to your planned budget
6. Is there any further information you wish to provide in relation to your project (case studies or quotes) or the Digital Sisters grant program?
7. Please upload some photos to show the impact of your program.

**Top Tip:** Ensure all learners are registered in the [my.GoodThings website](#) before submitting your grant acquittal.
